The Pennsylvania DUI Association's 41st Annual Meeting

The PA DUI Association's Annual Meeting Planning Committee is proud to present registration materials for the meeting to be held at Seven Springs Resort on November 18 & 19, 2020. As a diverse organization representing the many aspects of impaired driving our intent is to provide a comprehensive agenda to assist professionals in their everyday work as we all aim to reduce incident of impaired driving on our roadways. The event will comply with CDC, PA Department of Health Guidelines, in addition to compliance with mitigation and safety measures in place at Seven Springs Resort. No onsite/walk-in registrations will be accommodated this year, we will only be able to serve pre-registered attendees.

In order to comply with the guidelines, set forth by the Commonwealth for COVID-19 mitigation, trainings will occur within "pods" no larger than 22 persons per group. Each registrant will have the opportunity to choose one "pod" from the three choices. The pod choices are: Alcohol Highway Safety Program, DREs recertification and Law Enforcement. If needed additional "pods" will be added. Participants must remain within that same "pod" for the duration of the two days. When registering please indicate which training "pod" is appropriate for your professional needs.

This year's event will provide participants with 10.5 hours of credited training hours for Alcohol Highway Safety School and 12 hours for DRE recertification.

Workshop Descriptions

Emotion Engagement- *Presenter: Jim Gregg*

Presenter Jim Gregg will take you on an emotion journey of why we need to take care of each other as professionals in our respective fields. It will take the concept of “I am my brothers’ keeper” to a whole new level. This presentation is funny, sad, truthful and powerful.

Generational Differences- *Presenter: Bill White*

This course is designed to provide students with a fundamental understanding and a different perspective of how generational differences can both positively and negatively impact the work environment. The course will discuss generational differences and similarities, as well as strategies to minimize conflict, improve communication and enhance work collaboration.

Prescribed Impairment-*Presenters: Leo Hegarty, Regional DUI Program Administrator, PA DUI Association & Craig Amos, Regional DUI Program Administrator, PA DUI Association*

This session will focus on the common prescription medications that can cause significant impairment. They will discuss general indicators of several commonly prescribed medications. The session will also focus on appropriate investigative techniques when a driver is suspected of being under the influence of a prescribed medication that could possibly causing impairment.

Cannabis and the Traffic Stop- *Presenter: Scott Davis, Regional DUI Program Administrator, PA DUI Association*

This session will focus on the prevalence of marijuana and drivers. Currently, medical marijuana laws have increased the number of cannabis impaired operators on our highways. As recreational marijuana could be on the horizon, officers need to improve marijuana investigative tactics. The session will focus on the investigative detention, the observance and documentation of clues of impairment associated with marijuana and the appropriate techniques to ensure a proper investigation is conducted.

Communication with Motorists- *Presenter: Corporal Carmen Yurek, PA State Police*

Corporal Yurek was a bartender before becoming a Trooper. He has a knack for talking with people. Police/violator conversations are vital to public perceptions of police officers in general. Improvement in communication improves the outcome of the encounter. Cpl. Yurek will provide some general tips and tools to improve communications.

DRE Updates- *Presenter: Dave Andrascik, PA DRE State Coordinator*

The Pennsylvania DRE Coordinator will discuss the Drug Evaluation and Classification Program growth, throughout the world, the country and here in Pennsylvania. He will discuss recent DRE case law, as well as statistical numbers, and program curriculum updates.

DRE Instructor Supervised Evaluations- *Presenter: Dave Andrascik, PA DRE State Coordinator*

All attendees will conduct an instructor supervised training evaluation. Subjects of evaluations will role play, and DREs will be required to reach the appropriate opinion of impairment. These evaluations are required for recertification and all participants will be engaged.

Impaired Driving Case Law- *Presenter: Ande Gonzalez, DRE, Lancaster County, Assistant District Attorney*

This workshop is designed to present, interpret and discuss institutional issues related to traffic, and drug and alcohol-related enforcement activities. Issues to be discussed include: DUI case law; implied consent, standardized field sobriety testing, Miranda issues, police liability and current decisions relating to office safety issues.

Driver's Licensing- *Presenter: Cori Doughty, PA DUI Association, Master Trainer*

This workshop will focus on court and legislative matters affecting driver's license suspension for DUI offenders as well as matters regarding ignition interlock. Participants will have ample opportunity to ask questions. This workshop is a must for anyone dealing with the DUI offender.

Recreational Marijuana-*Presenter: Cori Doughty, PA DUI Association, Master Trainer*

This workshop will focus on the data and outcome of legalizing the cannabis industry in states such as Colorado, Washington and California. Issues to be discussed will also include current trends in legalizing the Eastern seaboard.

Vaping- *Presenter: Chris Shanley, PA DUI Association, Master Trainer*

Does it seem that everybody who attends Alcohol Highway Safety School has some sort of vaping device? This workshop will explore the history of vaping from e-cigarettes to the most current devices. And believe it or not, its not just nicotine. The workshop will also explore the what other drugs are being used and the health problems created by using these devices.
